6. In totality how many dentists participated in the webinar and how many among them participated in the study, so that response rate can be calculated.
7. Since vaccination started in the month of Jan 2021 in Indonesia, why the questionnaire didn't include questions on vaccination status.
8. number of figures are more combine it to form 4 or at the max 6.
9. discussion lacks comparison with other studies, limitations and future implications of the study.
10. Overall the grammar and the sentence forming can be improved.

Line 123-124: Re phrasing of this sentence may be necessary

Line 124-126: Please mention the implications after conducting this study

Methods: Only "Methods "as per the guideline

It should include:

- the aim, and setting of the study
- the characteristics of participants

Discussion: should discuss the implications of the findings in context of existing research and highlight limitations of the study.

Too long discussion.
